UPDATE: USCA payment was received in the amount of \$1,062.55, currently balance is \$1,339.55

Other Business:

Don noted that a used canopy tent was not available to purchase, the new one purchased is a \$6,000 tent, we paid \$3,206.56. The lights and cords were donated by Scott Carlson. The canopy is available for USCA Events to any regional club, first come-first served. Pick up and return can be coordinated through Don. Rental fee (not set in stone) is \$300 for a weekend, usually such a tent would rent for \$1,200-\$1,300.

Don asked if clubs would like to donate towards the purchase of 4 sides for the canopy tent at a total cost of \$1,000. Please let either Don or Judy know. To date, the Whiskey Mountain, Lighthouse, Maine Schutzhund and Pine Barrens clubs have pledged to contribute.

2023 Regional Track Layer Seminar. We need more track layers. The seminar will be under the instruction of Don and Vadim. This will be club and regional levels, no certification required.

Don asked for a vote to adopt the Universal Sieger rules per Ivana's discussion. Motion approved, seconded and passed.

The bid for the 2023 WDC championship closes next week. UPDATE: the WDC will be held in Spencer, MA.
